

The Georgia Ornithological Society's Fall Conference

Jon Dunn has been chief consultant/editor for the National Geographic Society's *Field Guide to the Birds of North America*. He is the co-writer and host of the two-video set *Large and Small Gulls of North America*, as well as co-author of *Birds of Southern California: Status and Distribution* and the Peterson *Field Guide to Warblers*. Jon is a member of the Committee on Classification and Nomenclature of the American Ornithologists' Union and the ABA Checklist Committee, and has served more than 20 years on the California Bird Records Committee.
